### **What Information We Collect**

We may collect and process the following types of personal data:

- Identity Data (e.g., your name, title, date of birth)
- Contact Data (e.g., email address, phone number, postal address)
- Professional Data (e.g., job title, employer information)
- **Usage Data** (e.g., how you use our website, IP address, browser type)
- Marketing and Communications Data (e.g., your preferences for receiving communications)
- **Special Category Data** (e.g., ethnicity, health or disability information, where necessary and with your explicit consent)

We do not knowingly collect data relating to children through our website.

#### **How We Collect Your Data**

We collect data in the following ways:

- When you fill out forms on our website
- When you correspond with us by email, phone, or otherwise
- When you subscribe to our newsletters, events, or services
- Through automated technologies like cookies and server logs



### **How We Use Your Data**

We use your data to:

- Provide and improve our apprenticeship programmes and services
- Respond to your enquiries
- Manage applications, learner records, and apprenticeship funding
- Send relevant updates, newsletters, or marketing (only if you opt in)
- Comply with legal and regulatory obligations

We always make sure our use of your data is lawful, fair, and transparent.

## **Legal Basis for Processing**

We rely on the following legal grounds to process your personal data:

- Your consent (e.g., for marketing communications)
- Performance of a contract with you
- Compliance with a legal obligation
- Legitimate interests (e.g., improving our services)

### **Sharing Your Data**

We may share your personal data with:

- Government bodies such as the Department for Education (DfE) where necessary for funding and compliance
- Apprenticeship employers (where relevant to your apprenticeship)
- Service providers who support our website and business operations (e.g., IT services)
- Professional advisors (e.g., legal, compliance, insurance)

We will never sell your data to third parties.

### **International Data Transfers**

All personal data is processed within the UK or the European Economic Area (EEA). If we need to transfer your data outside of the UK/EEA, we will ensure appropriate safeguards are in place.

### Data Security

We take your data security seriously.

We have put in place appropriate technical and organisational measures to prevent



your personal data from being accidentally lost, accessed, altered, or disclosed without authorisation.

# **How Long We Keep Your Data**

We will retain your personal data only for as long as necessary to fulfil the purposes we collected it for, including legal, accounting, or regulatory requirements.

## **Your Rights**
